This free report can be done through the Texas Department of Public Safety at [records.txdps.state.tx.us/sosearch](http://records.txdps.state.tx.us/sosearch) When searching, do not enter a city and zip. Leave it blank to search records for the entire state. A statewide search is required by youth camp laws.)*

**CRIMINAL RECORDS CHECK AUTHORIZATION**

I hereby give my permission for Texas Baptist Encampment to obtain information relating to my complete criminal history record. I, the undersigned, do, for myself, my heirs, executors and administrators, hereby remise, release and forever discharge and agree to indemnify Texas Baptist Encampment and each of their officers, directors, employees, and agents harmless from and against any and all causes of actions, suits, liabilities, costs, debts and sums of money, claims and demands whatsoever, and any and all related attorneys' fees, court costs, and other expenses resulting from the investigation of my background in connection with my application to become a volunteer or employee.
